

### Appointment of Hui Ye as Chairman

### New Chairman – Mr Hui Ye

Helios Energy Ltd (ASX Code: HE8) (**Helios** or **Company**) has appointed Mr Hui Ye as a director of the Company. In addition, the Board of Directors of Helios has elected Mr Ye as Chairman of the Company.

Mr Ye is the Chairman and President of Beijing Chunhui Yuan Group which is a large and very successful private company with extensive interests in real estate, hotels, natural resources, education and entertainment.

Mr Ye was a graduate of Shenzhen University in 1988 and is a descendant of one of the most influential families in modern China's history. He is the grandson of Marshall Ye. Marshall Ye was the head of state of the People's Republic of China between 1978 and 1983.

Through Notable Pioneer Limited he holds a 50% interest in 394,734,485 fully paid up ordinary shares in Helios and 131,578,162 listed options each with an exercise price of A\$0.02 and each with a term which expires on 31 December 2021.

Notable Pioneer Limited is the largest shareholder of Helios with a 31% shareholding.
